Public session

Stannington Village

A resident of Stannington Village attended to express concerns about traffic in the village and that vehicles are speeding through the village along platinum way to get to Netherton Park. Concern was also expressed relating to parking along Church Road and the use of the southern slip road. The member of public suggested that the slip road be closed but also recognised that to do so would bring about the potential end to the bus services to and from Morpeth and Newcastle.

The Clerk explained that a meeting of members the parish council have met with representatives Northumberland County Council to discuss these concerns along with issues at Shotton Edge and a plan is awaited from Northumberland County Council.

One the plan is received then it would require consultation to ensure that the views of all residents are considered.

Netherton Park

Another resident attended the meeting to express concerns about traffic issues at Netherton Park.

- The original outline plan for the new development was for a 5.5m road and a 2m pavement providing access to the current properties and additional 85 properties
- In 2019 this was changed by Officers under 'delegated authority' to 4.8m and 1.5m, with no public debate or reference to any Committee.
- The report said it transpired that land was not available to meet the original plan. However, we know that the local landowner and his family were never approached to see whether they would

release some land. The landowner was also present at the meeting and expressed a willingness to provide land for a better access had he been asked in the past or now. The Officer report accepted that the new dimensions were sub-optimal and contrary to the Council guidelines but justified the decision by reference to some very outdated traffic survey data. In short, the justification was weak and based on estimated traffic volumes. While we were concerned about volumes given the contextual changes to traffic patterns in the intervening period, as, more importantly, the safety related challenges of vehicles passing and the risks to pedestrians were a serious consideration in our view.

The residents and the PC - challenged the decision on numerous occasions, providing evidence as to why we believed it was wrong based on safety, (also reminding the Council it had failed to recognise the two blind/semi-blind exits onto the access road). No one has ever received a clear response or justification, and the unanswered question remains - why was more effort not made to meet the original outline plan given that land was available?

Now we are close to the time when the haul road will be removed, and the access road and pavement will be updated by Bellway to meet the Planning requirements. This is the time to revisit the decision. As The Withers becomes increasingly occupied is that the volume of traffic has increased. Many residents, Kyloe staff and other vehicles use the haul road at the moment, but soon all traffic will be required use the access road, including farm vehicles, refuse lorries, utility vehicles, delivery vehicles, residents (112 properties), Kyloe staff and other office staff. Speeding is commonplace and is a problem and safety risk.

Councillors agreed to seek clarity and a meeting from Northumberland County Council.

Purpose of report: To update the Council on items reported.

Commentary:

- a) Following previous report to Council Report from local resident at last meeting two village residents have now expressed concern that the two remaining large mature Lime trees at East School Cottage have also now been partially cut down.
This was conducted by Power Grid on it is understood a request from the new East School Cottage owner/s.
- b) Long and comprehensive letter received from Mrs. L. Woodman a long-standing resident of Stannington Village, who has enquired whether anything more can be done to reduce traffic load and traffic speed through the village particularly on Platinum way from Northbound Slip Road from the A1. She has stated to me that the road is increasingly becoming a 'rat run' for traffic travelling to the new housing schemes at Netherton Park etc. and Station Road areas. She has requested closure of the Northbound slip road to all vehicles but Buses and Emergency Service vehicles. Mrs. Woodman has also included complaints about the state of the village verges and the dangerous parking on school days by parents/carers parking in The Glebe and directly on the Church Bend. She included photographs of the situation.

The Parish Council Clerk is to circulate Mrs. Woodman's lengthy and detailed letter to all Councillors.

- c) Mr. & Mrs. S. & A. Lamb village residents have expressed the same complaint again to me regarding the increase in traffic and speeding vehicles through the village. He has suggested that the Northbound slip road be changed to a bus and emergency vehicle lane only with a camera to record non-compliant vehicles.

Trees reported to Northumberland County Council. Mrs Woodman was present at the public session and details recorded above. Mr Lamb's comments noted – see above re plans for a public consultation.
