Purpose of report: update for the Council on matters affecting Stannington Parish

Glororum Farm:

Since October 2017 the signage provided by NCC at the east junction, along with signage along the Construction Route for the Bellway development at St Mary's has been permanently removed or periodically missing when the grass verges are cut.

This construction traffic has been using this route for over 11 years and the ONE-WAY SYSTEM works when it is followed. In particular the signage at the East End Junction of the Glororum route has had to be re-errected by the residents time and time again due to it being left in or on the hedge after grass cutting or even in the adjoining field! It is now missing.

One of the main signs was removed by A1 England when the footpath here was upgraded, never to be seen again and also never replaced. Despite many emails to the NCC Highways we are no further forward. After 10 months this is disgraceful and extremely embarrassing! The residents at Glororum feel that permanent or temporary permanent signage would solve the issue as the grass cutters would be unable to move them. Controversially similar signage within Stannington Village is always in place.

Cllr Brown has offered to drive the route with NCC Highways to point out where all the signage was so that it can be reinstated. This offer has not been taken up.

Bellway have agreed to inform all their contractors of the ONE-WAY SYSTEM but how can we expect them to follow the agreed route if there is no signage to follow. If there are no signs to see then the wagons do not follow this system. This causes danger to all road users and to the road itself as damage is done when wagons need to pass each other as there is no room to do this.

Recently drainage works have been carried out at the Well Hill Opencast site and although the drivers know they need to follow the ONE-WAY SYSTEM they have not done so causing chaos to residents and local farmers at this busy time of year.

An unlocked jaguar car has been left outside the village hall noticeboard. The noticeboard cannot be accessed. The old fence that was taken down by Karbon Homes has been left and tree debris has been left by the bus shelter. The trees by the new fence need to be clipped. The proposed extra light near the Ridley Arms is acceptable to residents. The tip in the cemetery needs to be bulldozed, it is unsightly. An enquiry has been made about the bench by the playing field which was discussed and agreed. There have been more thefts from the cemetery, a spray head has been stolen. The flower beds in the cemetery to be adopted. The bottle bank area is being used as an unofficial dumping ground again. There are signs missing from the area which need to be replaced. Enquiries concerning the flag pole and the defibrillator have been made.

Actions Requested: The Parish Council will enquire as to the position of the abandoned car as the normal function of the noticeboard cannot be carried out. The Parish Council will notify Karbon Homes of the issues regarding the fence and tree debris. Ask NCC to clip trees by new fence. Organise flower beds in the cemetery. Level cemetery tip. Replace bottle bank signs and remove rubbish. Report update re the flag pole and the defibrillator.

St Marys Park

Commentary:

Purpose of report: To update the Council on complaint received from Stannington Village Hall Committee, Complaint regarding waste bins in A1 Laybys. Continuing car parking dangers near to chicane

Commentary:

1. At the meeting of the Village Hall Committee a complaint was raised with me relating to the general untidy state of the village particularly in relation to the verges and the central reservation in the main road through the village being full of weeds. 'Doreen Worswick asked Malcolm could the parish council see that the village be tidied up weeds, rubbish etc. Malcolm said he would see what he can do'.

Action requested: Councillor Scott to contact raise the issue with the Council at the next Parish Council Meeting

2. Concern raised by resident of Ridley Cottages about the overflowing waste bins located in the A1 laybys. Can these be emptied more regularly during the summer months?

Action requested: To request the Parish Council to discuss and request the County Council to empty more during the summer months

3. Further complaint from a resident of Elizabeth Square. Despite a new fence being erected adjacent to the main road through the village it is still noted that some residents are parking close to the chicane and are now just climbing the new fence to go to their residencies. This causes narrowing of the roadway at the chicane approach and is a safety issue.

Action Requested: Councillor Scott to raise this issue again to explore if any further action via the parish Council be taken relating to this.
