#### FOOTBALL FIELD.

Owners of dogs are letting them foul on the field where children are playing. They are cleaning up after their dog but there is a concern about residue being left could affect children's health.

#### BEECHLEA.

Speeding traffic have become a problem entering into Beechlea where children and parents cross to go to school this along with the limited visibility as cars park down towards church road causes a hazard.

#### MILLENIUM TREE.

Maurice Stewart has asked me to report the gate post is rotten on the entry gate to tree area.( corner of church car park)

#### FOOTPATHS.

Over the past years a lot more pedestrians are using our parish footpaths.

#### Footpath 1.

It has been brought to the parish council that the footpath along the Great North Road from Netherton Park road junction north to the garage at the top of Station Road is in need of some major repairs or in parts relaying the path completely. I have reported this in the past. Parishioners have asked if a bench could be placed on the side of this stretch of path.

## Footpath2.

Walkers from Morpeth / Hepscott Park, walking south to Station Road and beyond come to a path dead end approximately 200 metres from the junction at Hepscott Park and then have to walk on an uneven grassy and in places muddy verge till they get to the bottom of Station Road when they can either go up Station Road footpath or cross the road and take the footpath to Nedderton and beyond.

# Purpose of report: To update the Council on items reported. Commentary:

- a) Complaint received from Mr John and Mrs Margaret Richardson from St Mary's Church, Stannington, stating that the Beech Hedges in The Cemetery now require trimming back from the central pathway.
- b) Complaint received from resident Mr W. Stewart regarding an unsafe gate post leading into children's playground. The post is rotted at the base is very loose and requires replacement as a safety issue.
- c) Notice Board at St. Mary's Park is in a poor state of repair and is no longer water-tight. There is no working lock. Repairs or replacement required.
- d) A fatal road accident took place recently at the junction of Blagdon Lane and Old Great North Road. This follows another two bad collisions a week or so prior to this.

A couple of residents including myself have also had near misses at this junction recently. Can any pressure be put on to NCC for a study into the safety of this junction and whether improvements can be made. The recent building of large housing developments at the East end of Blagdon Lane on the A1068 (Arcot Manor and Foxton Mill) have undoubtedly created a larger traffic flow on this road and junction.

Very large trucks coming off the A1 to Cramlington (particularly to the Biomass Power Plant) have great difficulty in negotiating the junction should there be traffic attempting to turn right on to Old Great North Road to go to the A1 North. This can involve cars etc having to reverse back if they can to permit the truck to negotiate the turning. Furthermore the vegetation is constantly allowed to get out of hand again thus preventing traffic from seeing fast vehicles approaching from the South of Great Old North Road to travel North.

  - The group has asked that 2 seats are positioned in the Parish (one commemorates WW1, the other WW2). Three sites were suggested. Two benches may be placed on Platinum Way (to replace the old current benches) with the proviso that the doggy bin is moved further from the seat position at the Northern bus stop. The other site could be for the WW1 bench on the embankment opposite the WW1 plaques (there is a seat there at the moment).
  - The WW2 Group has also agreed to give the Village Show Group the management of the marquee.
  - A hot composter will be purchased for Stannington First School to complement their Forest School scheme, the donated Air Raid shelters and this will also fit very well with the "Dig For Victory" slogan from WW2. The cost of the composter is £500.
  - A donation of £250 has been proposed for the upkeep of St Mary's Church and a similar donation has been proposed for Blyth Battery who continue to support Stannington Parish by attending the Village Show and who were crucial to both the WW events.
  - The remaining monies, approximately £4k, will be put aside to support Stannington Parish Council and the proposed plans to renovate the Hearse House.

The council agreed to purchase the new seats with a donation from the group and agreed to place then next to Howard end and the Vicarage. It was also agreed that a small village library be purchased for the school to manage.
