74. Public session

A resident asked about ownership and responsibilities for leaning headstones in the old church yard. The Clerk explained in depth the process of closure and that ultimately Northumberland County Council is now responsible for the care and maintenance although the Diocese may also need involvement. The Clerk agreed to notify Northumberland County Council about one stone in particular which is leaning near the road and footpath.

Mr Whiffing of Green Close asked about the treatment of trees on the boundary of the Village Hall and his property on Green Close. The Clerk confirmed that instruction had been issued to North County Tree Surgeons to trim the trees and that the Village Hall would be asked about his request to access his garden for drainage purposes.

There was also concern about litter on the bridle path near the A1 and Northumberland County Council are to be informed.

Stannington Village

Commentary:

Stannington Village has a new pavement from Green Close to the Village Hall car park, this has taken a long time to organise and we must thank County Councillor Eileen Armstrong for pushing this through. Beechlea has been resurfaced, however there are still areas within the village that require repair particularly the road from the village through Catraw.

We requested the road sweepers and the drains to be cleaned and it is hoped this will make a big difference to the problem with surface water at certain points in the village. A request for a sign to be erected on the bus shelter that houses the defibrillator has come forward. Some residents are unsure where the defibrillator is. A notice in the village hall and the pub would assist too. A resident has reported the debris and litter around roundabouts and link roads around the parish and beyond.

The account for the WW1 fund has now been set up and will be monitored by the Parish Council.

A suggestion to erect a granite stone to inlay the 36 named plaques of the local men who perished in WW1 has been made. It may be positioned opposite the fountain so that it is visible to all.

Stannington Station Road

Commentary:

Purpose of report: To update the Council on Glororum route

Commentary:

Glororum:

The accident on 10th December 2018 severely damaged the roadside 'Junction' warning sign. It is still sitting beside the damaged hedge and needs to be removed and replaced. The junction road surface paint needs to be repainted at the West end junction.

The LH lane heading East towards the final corner on the Glororum route has begun to deteriorate again. There is also a huge pothole on the corner causing vehicles to drive in the middle of the road on a blind corner – we have reported this on the NCC website too.

The litter along the roadside is dreadful and is a hazard for wildlife and livestock. This has also been reported on NCC website.

Clifton:

The litter coming off the A1 into Clifton and up onto the A1 coming out of Clifton is also dreadful and gives a very poor welcome into Morpeth. There is also some metal debris left from a recent accident? Can we report this to Highways England please?

Please inform NCC of the above hazards.

Please inform Highways England regarding the rubbish coming off the A1 if this is their responsibility.

a) Local resident has expressed concern at dog fouling in the Village and in particular on the grassed areas opposite the Old School House in Church Lane. Could signage and dog waste bins be provided in the village.

- b) Has any further progress been made with the provision of a bus service to Manor Walks Shopping Centre in Cramlington a couple of days a week? Has the local community bus service provider been consulted about this as yet? Awaiting Northumberland County Council
- c) Has any further progress been made regarding the re-siting of the Village Notice Board to the Main Bus Stop? To be moved by K Clark
- d) There has still been no provision of a grit bin at the top of the Elizabeth Square bank. Was this ordered? Ordered.
- e) Unsure if this is the correct platform for this but was asked by a villager if the Parish Council are able to approach the local police regarding anti-social behavior around the Village Hall when meetings are going on. There have been groups being disrupted by three particular children from the village on more than one occasion.

- a) To examine the provision of suitable signage relating to the prohibition of dog fouling and dog waste disposal bins.
- b) To contact the local bus service provider to explore the possible provision of this service.
- c) Ascertain costs and try to progress over the upcoming better weather.
- d) To progress provision and siting of grit bin at top of Elizabeth Square bank.
- e) To look to consult with Local Police representative (P.C. Went) regarding the issue relating to item (e) above.
