Stannington Village Commentary:

Councillor Carins met with the new NCC tree officer and walked around the village to point out issues with diseased trees and also to give an update on the replanting scheme by the bungalows on the Great North Road. There is infrastructure in the form of concrete and possible utilities under the area that had been chosen as a potential planting site. If the new trees are planted further back, towards the bungalows, they may cause issues as they mature. Fruit trees would be a compromise, height and structure would better fill the area. The fruit would encourage wildlife and act as a community orchard. Pear, apple, plum and cherry trees would make an attractive addition to the crescent.

A large conifer has been partially felled in a resident's garden. The resulting timber was then dragged and has been fly tipped behind the northern bus shelter. NCC are aware and it is believed the resident was scammed.

New flags have been ordered to replace the union flag and also to enable residents to acknowledge other important days throughout the year.

Councillor Carins attended a liaison meeting at Netherton Park. The notes from the meeting are attached to the email.

Councillor Carins has been approached by a local prescription and medication free delivery service company (Mail my Meds). Fliers have been delivered around the Parish and they would like to attend any future community events to meet local residents. As many residents did need help collecting their meds, during the pandemic, this will be a welcome service.

The new planters around the Parish have been welcomed although some residents suggested that the ones coming into village from the north could be bigger or double up on each side.
