### Stannington Village Commentary:

Litter is becoming a problem on the road next to Swan Farm. Residents have inquired whether Stannington Parish Council can supply litt pickers, black bags and gloves.

Maurice reported a damaged gate post in the playground and a broken rung. Water is getting under the new surfacing in the cemetery car park. A salt bin has been requested for the cemetery car park. The bulb needs replacing in the north bus shelter. The lamp post is still off on Church Road.

The council has received good feedback regarding the flooding issue on Church Road. The issue has been solved.

Stannington School headmistress, Alex Palmer, has reported a problem with school space. A meeting is being organised by Councillor Eileen Armstrong and the Chairman of the School Governors, to include Councillor Carins, Alex Palmer and other interested bodies to look at a solution to the overcrowding issue.

Councillor Carins has been liaising with the residents of Netherton Park in relation to the Bellway development. The Parish Council and the residents are still waiting for a response regarding the lack of debate or answers to the access issues and the tree destruction on the Drive. The residents have made a formal complaint to the Chief Executive, Democartic Services, Senior Planning Officer Rob Murfin and Guy Opperman MP. The Morpeth Herald has written an article regarding this issue and the residents intend to approach other media organisations. The Residents are forming a liaison committee group to work with Bellway representatives, NCC Planning Officers and Stannington Parish Council to keep residents informed of any issues during the construction phase of the development I.e., noise, dust, utility interruptions and traffic control.

Councillor Carins has received another enquiry regarding a library/noticeboard on Station Road.

**Actions requested:** The council to consider litter picking request. The playground damage to be repaired. To consider a salt bin. Request, again, a replacement lamp post bulb. To organise a bulb replacement in the north bus stop. To report back to the council the outcome of the school meeting. To report back to the council any updates on Netherton Park.

**Commentary:** 

#### Glororum:

There is also a huge pothole on the blind corner causing vehicles to drive in the middle of the road on a blind corner – we have reported this on the NCC website too. This has been filled

with gravel chips but has opened up again. As this keeps happening, I think a longer term solution needs to be looked into. This has opened up again and now full of water.

Also heading down to this blind corner heading East the route surface has started to break up...this happened before the route was resurfaced a few years ago.

The large grey gravel which was used to fill in between the route and the hedge on the East carriageway needs to be topped up as it has become embedded by passing traffic – in the main this has worked as it facilitates wider vehicles passing each other.

Morpeth Litter Group have kindly collected the rubbish from the verges on the Glororum route. Is there any temporary signage placards that can be put up to remind folk to not throw litter?

The sharp-edged curb on approach to the East junction has caused havoc again and split another tyre.

As mentioned before, there are over 20 individual signs at the East End junction (Clifton end) and these are very distracting and confusing to motorists.

Please inform NCC of the above hazards:

- request inspection of the Glororum route with a view to add more gravel Agreed
- strengthen road where is it breaking up report to NCC
- remove / replace sharp edged roadside curb report to NCC
- look to reducing the amount of signage or sharing poles 'totem pole' effect refer to NCC

#### REPORT TO THE COUNCIL

Purpose of report: To update the Council on all issues raised by residents and others

#### Commentary:

- Complaints received from Village resident and a delivery driver regarding the dangerous and deep potholes on the main road through the village and the bad state of the road through the village. These potholes have been reported to the County Council website for repairs.
- Continuing complaints from a village resident regarding the dangers of the Northbound slip road from the A1 into the village. The free standing No Entry signs provided by the County Council Highways Dept at the Slip Road have fallen over. – report to Northumberland County Council
- Request again received for the Council to look at the potential of closing the high-speed slip road off the A1 to prevent traffic including large HGVs from driving through the village and treating it as a 'layby' to park at the North end for rest breaks etc. – Not

- agreed at present as this is a complex matter and could adversely affect bus service revival attempts.
- Complaint received about the very bad state of Station Road and the amounts of mud being left on the road during building works. This poses a danger to traffic. – Refer to Northumberland County Council
- Local Resident Steve Lamb is continuing with his issues and campaign regarding the request for 'silent' road surfacing on the A1 Village bypass. He has received a reply from Guy Opperman our Local M.P. who is looking into this issue with Highways England.

#### **Actions requested:**

- To discuss the bad state of the road through Stannington village, the potholes situation and to have the potholes properly patched and repaired – refer to Northumberland County Council
- To request the County Council to inspect the road through the village and look at a possible full resurfacing schedule – refer to Northumberland County Council
- To request the County Council to lift the No Entry signage and secure the signs better
   refer to Northumberland County Council
- To discuss the ongoing situation with traffic from the A1 coming through and into the village at speed and using it as a layby. Litter on North End roadside - refer to Northumberland County Council
- To request that the building and groundworks contractors on Station Road clean the road properly if it becomes muddy etc. – refer to Northumberland County Council
- To liaise with Mr. Lamb and continue to monitor his ongoing correspondence. Possibly request Mr. Lamb to copy The Clerk.

#### 81. To consider Councillors items

- 1. Church road footpath There is a hedge overhanging Church Road refer to Northumberland County Council
- 2. Litter there is an increasing issue with litter on the A1 and roads from Station Road to Stannington Village, over littering is also taking place in the church car park and also in the area of The Vale Refer to Northumberland County Council and order several new bins in the new financial year for deployment.
- 3. The Playground (to include repairs) Post on the gate needs repair including full inspection of play are and any subsequent repairs. Ask Northern Services to repair. In addition, it was agreed to paint the goal posts in the summer when the weather is better.
- 4. Noticeboards/library New notice board to be placed at Station Road incorporating library. Contractor is on furlough so action once this has ended.
- 5. Planters THC landscapes will replace all planters in the summer with 'sleeper' style boxes.
- 6. Tree planting Cllr Carins looking at options and to report back.
