2. Public session

Netherton Park

Residents from Netherton Park attended the meeting to express their concern at the proposals for the Netherton Park Trustees to seek planning permission for the development of the site following the closure of the childrens' open units.

Mr Haggie represented the residents and outlined their position:

- Preference for the status quo
- The need to protect the semi-rural nature of the site
- Pleased with the retention of the green spaces in the development
- Questions raised about the suitability of houses having a boundary with the secure unit which is a 20' high wall
- Concerned about the boundary of the development with North Bungalow
- The creation of 'The Boulevard' will impact on the residents of The Drive
- Concern that a proper environmental assessment has not been done to determine the impact on Bats and wildlife corridors
- The development proposed should match the current density
- There is a desire for more green space to match the current green space available

Stannington First School

Mr Hepton was present from the governors of the School. He described in some detail the proposals for a new community building at the school which could be used by both the school and the community. The scheme now involved a standalone building which would be fully accessible. £50K had been secured in grant funding and a gap of £10K now existed. As the building is mobile it can be moved if the site is redeveloped in the future. A number of funding applications were still awaiting response. Stannington Station

The Clerk and Chairman attended a meeting with Tracey Brady concerning the liaison committee. It was decided that the liaison committee had run its course and that a quarterly meeting between, Ronnie, the Clerk, Tracey and the PC Chair would be sufficient from now on. Handyman

- The Clerk has addressed all previous issues.
- Beachlea seat is beyond repair and dangerous.

- The people in the flats with the white handrails have repeatedly asked the housing association if they can have a different colour on the rails but been ignored. The Clerk read out a letter from ISOS explaining that this was a requirement of the Disability Act.
- The fences and hedges in that area also need to be addressed.
- Behind the garages at Beachlea there is a large amount of rubbish accumulating. Reported to NCC.
- Children's play are sign obscured by fallen tree branches. Resolved.
- The play area has flooded on top of the main drain. Maurice has asked if he can put a lateral drain in to alleviate this problem.
- Drain in opposite front of the old Vicarage.is spouting water and backing up. Reported.
- The 30 mile an hour sign by Swan Farm has rotted away, can it be removed? Is a sign still necessary there? Reported.

Glororum

- Since the Fireclay application was granted the wagons should have been using a ONE-WAY route and therefore only coming 'down' (heading east) the Glororum route. Unfortunately a few are ignoring this and these have been reported to Hargreaves.
- Bellway have been asked to use the same route and some probably are but not most...we know this may take a while to filter through to drivers as they do use many different contractors. Some weeks deliveries to this site are low, but some weeks they are very busy with a wagon every 5mins.
- There are also new properties being built with Tranwell Woods and alterations/extensions, which generate many more wagons, cement lorries, delivery vehicles.
- So all in all residents are no better off....in fact the road is breaking down daily.....we have as much traffic as ever and still huge wagons trying to pass each other so the verges are getting even more narrow and some have disappeared completely and the roadside ditches are so heavily compacted with the verges which have been driven into them that they are no longer there.
- What make this situation worse for the residence is that we knew this would happen and the Highway Department took no notice of our concerns. Now I would class the route as Dangerous and yet still nothing has been done. We know that Hargreaves have to restore the route once they are finished but they are only 10 months into a 3 year site! And why should they restore a route which the County Council have never maintained and which is also being used by another developer?
- A resident rang NCC last week and was told the potholes will be filled in this month! Just the potholes?! The surface is cracking, lifting, crumbling, the road edges are flimsy and in some areas totally demolished, the verges are to reinstate, signs have been hit and are lying in the road!, passing bays were to be upgraded. You have to 'weave' around holes (some over 12"deep) and uneven surface where you can see 3 levels of surface are demolished. An accident is going to happen.
- CI Brown emailed Joe Nugent to ask what is happening but have received no reply as yet.
- CIr Brown also emailed local Policewoman Andrea Teasdale regarding the speeds we experience on this route but received no reply.

Clifton

The grass has been recently cut.

Rubbish is still a problem as it is thrown from cars driving through Clifton & either our Handyman or a Clifton resident on a weekly basis (or more often) collects a barrow full for the bin.

Speed tapes have been placed at the entrance & exit into Clifton & at other junctions on & off the A1. A black box was also attached to a telegraph pole outside Clifton Stables. Clr Strachan contacted Sky High Technology who erected the box & their representative told her that the Highways Agency are collecting data from all junctions on & off the A1 from Seaton Burn to The Borders.

The explanation is as follows:

There are a number of aspects to the survey as follows:

- Bluetooth detector survey: this involved placing Bluetooth detectors at 59 locations around the A1. These detectors pick up signals from any Bluetooth devices in passing vehicles (mobile phones, laptops, in-vehicle systems) and if the same device is picked up by a second detector this provides data on the distribution of travel around the area and how long each journey takes (note that for privacy reasons the Bluetooth reference number for each device is assigned a new unique reference by the system which we can't trace back to a specific device when we get the data).
- Automatic Traffic Counters (ATCs): these are tubes placed across the road which count the number of vehicles passing that point. We located these in the same 59 locations as the Bluetooth detectors so that we know the total number of vehicles at each point (since not every vehicle will contain a Bluetooth device). There were also four other locations on the A1 itself that we surveyed with these ATCs.
- Manual Classified Counts (MCCs): these involve installing temporary video cameras which record videos of the location being surveyed. The data collected from these are the total number of vehicles of each type (e.g. motorbike, car, car with caravan, HGV, van etc.). This type of survey was carried out in 6 locations on the A1.

The Bluetooth detectors and ATCs were in place for two weeks and the MCCs were carried out on three days during this two week period. We are reaching the end of the survey period now so the survey company should be removing the equipment at some point this week.

The survey won't affect traffic movements or junctions. The data is to be used to develop a traffic model of this area of the A1, a traffic model is a computer simulation of the road network to represent traffic movements and enable the assessment of proposed changes to the road network.

Clr Strachan will contact a James Finch at the Highways Agency for further news of any alterations to junctions within our Parish & also for the number of vehicles using the roads within our parish.
