7. Chairman's annual report

2021, so far, has been another very different year for all of us, we are now experts at remote meetings within our work life and with our family and friends. Our children, their parents and carers have worked exceptionally hard with remote learning, they should be congratulated. We now understand how hard our teachers work and how dedicated they are to our children, specially in such difficult circumstances. Many of us will have been unable to spend Christmas with our loved ones, missed special birthdays and anniversaries and, sadly, been unable to attend funerals. Weddings and holidays have been postponed, sporting and social events have been cancelled.

However, from the 17th May, things will hopefully improve for everyone as we start to get back to a more normal way of life. Many of us have had our first and second vaccines and with this our confidence in meeting up and attending meetings and events will improve.

The farm shops and food outlets which have helped so much during this difficult time. Having access to fresh produce, a takeaway pizza and a curry made the lockdown more bearable. Thank goodness for our lovely walkways too, we have all got to know our fellow residents better.

Our Parish Councillors' have many duties and these have continued during lockdown.

One of these duties involve consulting on planning applications; We have commented, on behalf of the Parish, at remote planning meetings at County Hall. We speak for and against planning applications that come before the council. Our comments are always based on planning facts and on our knowledge of the parish which is greatly aided by the residents who live here. We are still waiting for the adoption of the Local Plan. This has been delayed due to the pandemic. Stannington Parish Neighbourhood Plan has proved invaluable in informing Northumberland County Council on all things relating to the Parish. The Parish Council will continue to support our red squirrels and we are, again, most grateful for all the hard work Mark Legard puts into the preservation of these beautiful creatures. We support, maintain and improve the grounds across the Parish. We report potholes, fly tipping and any other issues that affect our

Purpose of report: To update the Council on all issues raised by residents and others

Commentary:

- a) Resident complaint received regarding there still being no action by County Council on deep potholes on the Main Road through the Village.
- b) On the Bank Holiday on Monday May 3rd, 2021 there was very severe traffic congestion again at the entrance to Northumberlandia. Traffic entering Blagdon Lane from Cramlington was backed up a considerable distance along Blagdon Lane past the Snowy Owl Inn and across/along the A1068 (Fisher Lane) dual carriageway towards the roundabout to Cramlington. Cars were parked on the side verges of the main road. This was caused by the car park to Northumberlandia and the adjoining field being full. Signs stating that the car park was full were displayed with an attendant at the entrance making vehicles turn around in the entranceway. Many cars were still attempting entry and as this is a small entrance the turning vehicles were creating a huge backlog of traffic as were those parked on the roadside. This road is used by many vehicles in a day and the traffic congestion at Northumberlandia is becoming more of a problem and creating a road safety issue at the entry/exit point. This can only become worse whenever there is a dry day and when better weather arrives particularly at weekends and at holiday times.

Actions Required

- a) To contact the County Council again to make a stronger case and ask for the potholes in the Village to be filled as soon as possible to the required Standard.
- b) To look at the traffic problems being caused on Blagdon Lane by the Northumberlandia entrance/exit point and investigate the possibility of a roundabout being constructed here or additional parking space or an in and out gateway for the attraction.
