Stannington Village

Commentary: The path behind the Glebe has now been cleared and a resident has thanked the council for their swift action. The Glebe has had new water pipes installed and the state of the road, there, has warranted an inspection from Highways. The road leading from the village to Catraw is being considered for repair following a report from Councillor Armstrong. Councillor Carins has requested a walkabout with officers from Northumberland County council to look at all the potholes and pavement issues in the village. The state of the kerbsides around the village has also been brought up by a resident. These will be looked at during the walkabout.
