REPORT TO THE COUNCIL

Purpose of report: To update the Council on matters affecting Stannington Parish

Stannington Station Road

The sign at the Station Road services has now been changed and residents are pleased with the outcome.

Councillor Carins has had a meeting with County Councillor Darwin concerning issues at Willow Homes and Councillor Darwin will chase this up with the Planning Department. The County Council has been informed but to date there has been no response from them.

Action: To monitor the matter and liaise with Councillor Darwin

Stannington Village

The defibrillator in the southern bus shelter is to be relocated to the exterior of the village hall, this will make it easier to be seen and located.

The Storm Arwen caused a lot of damage and disruption to everyone in the Parish. Northern Powergen have scoped the village hall in order to provide a generator in the event of another severe weather incident. This will mean the hall will be used as a warm hub were any residents, suffering a loss of power, may come, get warm and enjoy some hot food and company. The Hall is registered as a Warm Hub and will have an open day during Village Hall's Week. Plans to upgrade the hall are being considered and the Parish Council will be asked to support these changes and for advice.

The School's Christmas luncheon in the Village Hall was a lovely event for the Parish Council to be involved in and will now be repeated annually.

The Parish Councillors expressed their deep sadness on the untimely death of Shaun Scott. They sent their condolences to Claire and Lois. Claire and Shaun have always been great supporters of all things Stannington and played an integral part in the WW2 Event, the Jubilee Events and Shaun was very helpful to Councillor Carins regarding his immense knowledge of trees and issues the Parish had in the village. Over 370 people attended his funeral which shows how much regard he was held in. Claire has asked that the Parish Council to oversee the very kind donations in Shaun's memory to benefit the community. This may be a special bench or tree, the Parish Council will work with Claire and Lois as to what would make a special memory in Shaun's name.

Action: To liaise with Claire Scott and to keep the Parish Council informed.

Coronation May 6th 2023

The arrangements for the Coronation in May are well under way and an exciting day is planned for the whole Parish. It will centre around the Village hall and be a "street party" weather permitting. The Hall and a marquee will be used as back up so it won't stop the celebrations. A magician, face-painter and entertainer have been booked. The Parish Council are also sponsoring a ticketed event, on the evening of the Coronation, with a band and a dance in the Village hall. The Parish also look forward to the return of Stannington, Make, Bake, Grow and Show show in September.

Action: To keep the Parish Council updated on issues concerning the Coronation. **St Marys Park**

The issue regarding the residents complaint about the planning application 22/02923/FUL | Provision of playing field, including pitch drainage, and landscaping of viewing mounds. | St Mary's Hospital Development Site St Mary's Hospital Drive Stannington Northumberland NE61 6BL is still unresolved. Sink holes have been reported by residents and featured in the local press.

Action: To support the residents and work with Bellway and NCC to ensure that the area is put back to a state that is agreeable to all.

Netherton Park

The work at Netherton Park now continues but is being compromised by the bad weather. Any issues that arise with Bellway are being dealt with through the weekly meetings that the Residents representatives have with the Site Manager and the backup of communication with the Construction Manager as and when appropriate. As has been reported before, the main operational issues arise from the activities on the Drive.

The show home is open and generating interest. The 3 completed houses on the Drive (the 4th is the show home) are being finalised/landscaped for occupation by the end of January, at which point the focus of activity will shift to the main site. The Drive will still be subject to site vehicle traffic but it is expected that the number of operational issues on the Drive will reduce significantly.

The more substantial concerns, as has been reported consistently over the last year or so, relate to:

- the main access road, speeding, safety and the fact that the Parish Council or residents have not seen or had any description regarding the final Road Safety Plan. It is understood that the Road Safety Plan is something that Bellway have to produce but the Council have to oversee and approve which is why concerns are being addressed to the Council Highways Officer. Everyone concerned is aware of the issues regarding safety, speeding etc that these issues have been consistently raised since before the Planning Approval was granted. It is very disappointing that the Council have not responded to a series of requests for further information, or to a request to meet residents on site and review the situation or provided an explanation as to why the temporary speed bumps, promised before the school holiday period last summer, have not been put down or to where things are with the Road Safety Plan.
- the proposals for new security gates/system at Kyloe House. Residents asked the Council for more information on how the new arrangements would work, where the cameras were pointing, what they could see, where the lights would shine and when, what would happen if there was a delay/system fault in terms of traffic backing up onto the main access site and finally how the whole thing would look to residents and visitors. Residents suggested it could be moved further along the Kyloe entrance road, nearer to Kyloe House and out of direct line of site. Residents reminded the Council that this is their homes, and that these considerations were reasonable. Residents did not receive any reply to these questions, concerns and requests for information and the Council went ahead and approved the scheme.

Residents note and welcome that the Netherton Park Trustees (who own the land) have not granted Kyloe House approval for an extension that was approved last summer by the Council. While this does not have a particular direct impact on existing residents, it surely would have impacted detrimentally on the new development. Residents have asked if the Parish Council could approach the NP Trustees on their behalf regarding the security system on the grounds of community detriment.

Following a meeting with Councillor Carins, Councillor Darwin will organise a liaison meeting, to include residents, NCC, Kyloe House and the Parish Council.

Action: To support the residents and work with Bellway and NCC to ensure that a liaison meeting is held asap.
