20. General update from the Clerk

The Clerk advised that a response was received from Northumberland County Council who felt that the Parish Council had not made a reasonable ask for bus services in Stannington Parish. The Council disagreed with this statement because a very reasonable ask had been made, a service to and from Morpeth and Newcastle using existing services. It was noted that Northumberland County Council did not feel this was appropriate because it would delay

buses into Newcastle at the Haymarket Station due to congestion, even though this service had operated successfully in the past.

Resolved that:

The clerk seek a meeting with Arriva to progress this.

The Clerk also advised that an online survey was being developed for the whole parish in order to assess transport needs. Everyone should be encouraged to complete the survey and to assist neighbours to do so. Details of the survey would be posted on social media and also via posters in noticeboards etc.

The Clerk advised that contact had been made with Northumbrian Water relating to water ponding outside the Church and opposite the School. The water has been tested and it is not mains water so therefore a spring welling up. The Clerk checked old ordnance survey plans and a spring is shown on the plan. Purpose of report: To update the Council on issues raised

Commentary:

- a) I mentioned at the last two Council Meetings that there had been a vehicle fire on the Northbound slip road from the A1 leading into the village. I have again had villagers mention to me about the debris that has still not been cleared and has been left at the roadside for some weeks now following this incident.
- b) I reported a snapped/broken road sign to NCC. They have come and put a road cone over the broken sign to keep the sharp edge of the broken sign covered. The broken sign is still lying at the roadside.
- c) For Information. I reported an abandoned trailer full of waste near to seven-mile house. This has been removed and cleared by NCC.
- d) For Information. Snakeskin Maple Tree has been planted in the village at spot agreed. Plaque is ordered.

Purpose of report: Update for Council meeting

Commentary:

Stannington Village

Weeds have been treated around the village but there is still a need for road drains to be cleared. Recent flooding around the village was noted and the drains were unable to cope. Bus Shelters need to be cleaned. The roundabouts need to be addressed, they are untidy, a planter on each roundabout has been muted. The siting of the new flag pole and the re positioning of the plaque for Connie Dungait has, again, been enquired about. The football goal posts have been painted.

Action

To request a road drain deep clean from NCC. To organise the placement of the plaque and flag pole. To discuss the roundabouts and a solution. Organise a Bus Shelter clean.

Commentary:

Stannington Station Road

There have been no issues reported to date.

Commentary:

Netherton Park

The residents have requested support from the Parish Council and Councillor Darwin regarding the lack of a Road Safety Plan. It is important a plan is in place sooner rather than later on how traffic is going to be managed as the PC and residents concerns are going to be realised when the haul road is removed and all traffic is forced down a very narrow road. This is unacceptable. Residents are still having infrequent meetings with Bellway and most issues are dealt with immediately. NCC has been approached for a response.

Action

To engage with NCC as a matter of urgency regarding the lack of a Road Safety Plan.

Commentary:

Hepscott Park

Residents have been in conversation with the PC regarding the lack of housekeeping by Bellway. Residents have sent evidence (photographs) to the PC and these have been forwarded to the Enforcement Officer who has opened a case to investigate the issues. The hedges and entrance to the development are causing the most concerns and present a danger to vehicles line of sight when leaving the development. Renovations to the school and garden centre will further exasperate the situation. Residents have also requested the 15mph be reinstated, however, this was not a legal road sign. The PC has requested further information on the ownership of the road into the estate.

Action

To work with the residents, Bellway and NCC and keep the residents in the loop on responses from Highways regarding the road safety issues.

Commentary:

St Mary Park

The village hall will shortly reopen under new management. There have been several very well attended residents meetings and residents have engaged with Bellway concerning issues currently causing problems to home owners. The Band stand is being renovated and contaminated building material is being removed. Unfortunately, there have been further animal fatalities due to speeding vehicles.

Action

To support the residents and attend future residents meetings.

No news on any of the issues raised regard the Glororum route or signage. Holes etc have been filled in Clifton but not all.

The low path alongside the churchyard wall opposite school has had the holes filled. Road sweeper has been through the village today. As many of the children walk from the church car park is it possible to have the path swept too?

There has been water trickling along the path/ road kerb for weeks- possible water pipe leak? Water still here after road sweeping and appears to be trickling out from a certain point.

You can see that the leaves on the path are a hazard for pedestrians.

The church carpark also has a lot of leaf and tree debris. Could the team who cut the grass help out with sweeping this and the path please?

Action

To follow up on the above issues.
