REPORT TO THE COUNCIL

Purpose of report: To update the Council on matters affecting Stannington Parish

Minutes for Brenkley OCCS liaison and Community Benefit Fund circulated.

Stannington Village Commentary:

Road repairs at The Glebe have been completed to a very good standard.

Councillor Carins attended a meeting at the playing field with a representative of Playdale. The addition of a trailer to the tractor has been requested. The tractor will be green and the number plate will read "Andy 1". Councillor Robson will report, at the Parish Council meeting, the amount of money that will be donated from Andy Crewdson's estate and from his business partners. The equipment will need to be ordered before Christmas to enable the work to begin around March.

Notices regarding the removal of unauthorised equipment from the playing field were put up. The football net which has appeared on the playing field is still there.

Councillor Carins has received complaints from residents about the state of the cemetery car park, the flooding on Church Road and the grass verge. A resident has also asked if the lane running from The Fountain be tidied as the hedge is causing problems for pedestrians/cars conflict.

Councillor Carins had a meeting with PC Darren Stapleton in October to discuss various issues around the Parish. PC Stapleton will liaise with Councillor Carins in order to keep the Parish Council aware of any issues that may concern residents or businesses in the area.

Blagdon Estates are to repair the potholes in the hairdresser's car park and the lane opposite. The work will take place on Monday.

The War Memorial has been repaired by stonemason who made the original plaque. The new plaque is much thicker than the previous one.

Freeman Ridley has been litter picking and has tidied the Fountain area in readiness for the Remembrance Sunday wreaths. The wreaths will be laid privately to observe the current restrictions.

Pedestrians are still having issues with cyclists riding on footpaths in the Parish Signage is needed at the southern slip road from the A1 as visitors are still driving up the slip road the wrong way. A no access sign is needed.

Actions requested:

The Council to order the new play equipment from Playdale. The Council to look at clear cyclist signage and signage on the southern slip road. The net to be removed in the playing field. The

hedging be tidied by the Fountain. The Council to instigate the work needed for the cemetery car park.

Volunteers have continued to assist residents in the Parish. The SPNP Facebook page has advertised the support flier again, during the 2nd lockdown. Councillor Carins has been offered Christmas packs from Age Concern to help our residents during lockdown

WW2 FUND Commentary:

The children's book is now being printed and 150 will be distributed to the children at Stannington First School. The lottery tickets are now on sale. A curry night has been organised at Char Mausum for some time in December as the September night had to be cancelled due to Covid 19 restrictions.

<u>49. To consider matters relating to The Church carpark, grass verge and drainage</u> <u>issues on Church Road</u>

- Debmat £14910 + £810 for lining, all plus Vat (60mm base and 30mm wearing)
- WL Straughan £15195 + £795 all plus Vat (70mm single course) or £10945 for 40mm single course across the whole area.

Resolved that: The Clerk seek costs for the installation of a single 70mm Base Course across the car park area only, excluding the area already tarmacked and that this be agreed for approval before Christmas.

Verge works along Church Road were not agreed as the Clerk advised that Northumberland County Council would be likely to want to carry out this work themselves at the expense of the Parish Council. The Clerk/Chair to investigate. The Council confirmed however that this was a matter of extreme priority given the road safety issues outside Stannington 1st School.

50. To consider matters relating to the village playground - Chair to report

The Chair updated the Council on progress with the paly area and in particular the discussions with Playdale for the provision of a Tractor to be partly funded by donations from colleagues of the late Manager of Blagdon Estate and also from top up payments by the Parish Council. There was some uncertainty as to the funds available for the project and so it was agreed that Cllr Philipson seek written conformation of funds for the next meeting and that the Clerk finalise costs for the moving of the fence line and installation of the tractor. Councillors confirmed a wish to install this facility as early as possible in 2021.

51. To consider options for dealing with remaining WW1 merchandise

Cllr Carins, Cllr Scott, Cllr Tolson declared an interest and took no part in the discussion.

The Clerk updated the Council remaining stocks of merchandise from the WW1 event:

Books: Stannington for King and Country-Vol 1-110 Stannington for King and Country-Vol 2-7 Stannington for King and Country-Vol 1-72 Children's Book-6

Other: Tea Towels-25 Percy Postcards-89 Tank Postcards-98

A discussion took place on how best to deal with the remaining stock and it was decided that the Battle of Britain event group should retain the items to be used for fund raising for the forthcoming event.

52. To consider a grant to Stannington 1st School for £2000 relating to the provision of <u>a cycle track</u>

Cllr Carins and Cllr Brown declared an interest and took no part in the discussion.

The school were hoping to install a cycling/running track around the perimeter of the field. This is part of an initiative to increase daily activity for every pupil and also encourage pupils to walk, cycle or park and ride to and from school.

Aims are:

- To increase daily activity for every pupil and teach them the benefits of a healthy lifestyle
- To set up a school bike club
- To divert parking to the car park next to the village hall and encourage parents and pupils to Park and Ride or Stride from there
- To reduce congestion and improve air quality and safety around the school gates at busy times

The cycle track will cost between $\pounds 20 - 25k$ and the school has the majority of this funding (approximately $\pounds 18K$) secured already through sport funding and other grants. The School also has an additional $\pounds 3k$ for the purchase of bikes and a storage container.

The track would also be available to the After School club, the Brownies (when they restart) and school holiday clubs. A request for £2000 was submitted to the Parish Council.

Resolved that: this project be funded by the Parish Council to the value of £2000 and that the grant be paid immediately on completion of the work.

53.To approve the purchase of 5 speed signs £10540.62 + vat by single tender

Councillors considered a quote from Evolis for 5 speed signs including solar power facilities. This was a single tender as the units match the ones already deployed in Stannington Village. Councillors therefore agreed that consistent technology was important. It was noted that the signs could be programmed for any speed setting which was important given the impending speed limit change on Station Road.

Resolved that: the purchase pf the signs be authorised and that they be located at Station Road (2), Glororum (2) and Clifton (1).

54.Stannington Parish festival of bloom 2021 – Clerk to report

The clerk presented a Powerpoint presentation (appended to the minutes) on a proposal for a Stannington Parish Festival of Bloom 2021 in the hope that this event could proceed in 2021 in support of the Battle of Britain Event and also to raise spirits in every corner of the Parish following the ongoing Covid 19 Pandemic.

The event would involve businesses, residents, settlements, community groups, the school and St Mary's Church. A range of prises would be given for specific categories and it is hoped to gain some sponsorship.
