Purpose of report: To update the Council on matters affecting Stannington Parish, specifically around Glororum.

Signage:

The '30' speed signage has been replace at the east end of Glororum, thank you The '30' flashing speed sign is no longer working. There was a discussion on putting up one of the new speed signs which flash the speed a motorist is travelling at? I think one has already been purchased for the 'west' end of the route

Action:

Clarification on new flashing speed signs.

Speed:

It has been noted and reported to myself that the domestic traffic using the Glororum route is not keeping to the 30 speed limit and is 'flying' through at dangerous speeds. There was an accident where a car ended up on its roof due to driving too quickly around a blind bend. There was an accident last week when a vehicle did not give way to oncoming traffic resulting in a collision.

Action:

To report danger to NCC and request speed/traffic counting devices and possibly a mobile speed camera.

Rubbish:

The rubbish thrown from cars off the A1 on the Clifton slip roads and on the Glororum route is getting much worse and poses a direct hazard to wildlife and farm stock. I have not seen it as bad for many years. I have reported this before but unfortunately the situation has become much worse - possibly caused by the high winds. We have also had some fly tipping. This trail goes through Glororum, Clifton and on into Morpeth.

Action:

To report to NCC in the hope that a team can be deployed to clear it up. I am making this request again as no team has been to collect any rubbish.

Local signage:

Some of the directional signage and place signage in the parish is in a poor state of repair - rusted through, hanging off posts, and posts leaning at odd angles due to them being hit.

Action:

Report to NCC that maybe a signage survey needs to be carried out. As you requested David I have done this report but feel it is just for information purposes at the moment as I'm sure that NCC is busy with much more important issues due to COVID-19

Purpose of report: To update the Council on issues raised

Commentary:

a) A complaint has been made about the new potentially dangerous trip hazard and possible loose stones issue where a timber edged pebble 'bed' has been constructed on the Council verge adjacent to the main public footpath through the village to the rear of No 2 Elizabeth Square. Stannington Village (Mr. & Mrs. Burnham). This does pose a potentially serious trip hazard particularly at night and the loose pebbles if they get removed by any person could pose a serious hazard to traffic through the village and grass cutting machinery. Should this not have been constructed on what I am told by neighbours is Council Land.

Actions requested:

To contact the residents of the house to see about putting back verge as it was previously before the wall building works were carried out. Also, to check if repairs to the verge on the other side of the path are required.

b) I have received an email from a resident regarding the possibility of honouring the servicemen and women who served and trained at RAF Tranwell during WW2. Over 6000 air gunners were trained at the base during the last war. Many lost their lives in combat and during training accidents nearby. It has been suggested that a memorial be provided next to the one that is going to be located opposite the current water fountain in the village. It would not be suitable to have it located at Tranwell itself as few would get the chance to see it. Perhaps any plaque provided could have a picture of the main aircraft used at Tranwell airfield which proved to be a pretty disastrous aeroplane.

Here is the email I have received:

On chatting to you regarding your talk on the history of Tranwell Airfield it really hit home as to how many men with connection to the airfield sadly gave their lives either in combat or as the result of accidents. It came to mind to ask if during your research you came across the existence of a memorial, of one form or another, to these brave airmen. I know some are buried in Morpeth and that their graves are well looked after but that does not really constitute a memorial. If one does not exist, and if appropriate, is it at all possible for the matter to be explored.

Actions requested:

To discuss with Parish Councillors and look into the provision of such a memorial in the village. I am happy to investigate this and look at the provision and suitably agreed wording on a plaque.

86. Possible co-option of a Councillor

Two applications were received fro the cooption to the office of Councillor. After considerable discussion members decided to defer the cooption so as to allow a full process to take place with the

opportunity for both candidates to present their case to the council. A date to be fixed after the lockdown.

87. Emergency action resulting from the COVID 19 Pandemic

Noted that a considerable amount of work has already been undertaken. Three councillors and three representatives of the church have been working to support residents in the parish who are sheilding, those over 70, those on the governments 1.5m vulnerable list and thos self isolating as a result of COVID 19. Phone support, seeking shopping, signposting and other support is available.

Northumberland Council are doing a great job in signposting businesses to support and financail support. Also supporting the vulnerable and elderly.

Banks Mining will make a grant to the PC for community support.

Councillors recognised the significant impact on the parish, its economy and especially the health and wellbeing of residents. Councillors discussed how to support residents.

Resolved that: the council grant £1000 to the village show for distribution to groups and residents in dire need and that this be overseen by Cllrs Dickinson, Carins and Freeman J Manners.

The council further resolved that: should a resident die of COVID 19, given the severe economic hardship in the country, then burial fees be waived where the stated cause of death is COVID 19. Noted that no more than 8 people may attend a funeral and social distancing should take place.

It was noted that many services across the county and parish may cease as a result of the Pandemic, however maintenance of the cemetery would be prioritised. The play area is closed.

The post office is continuing to operate twice weekly for the benefit of the community and is operating a socially distanced service.
